UPON hearing the counsel the Court made the following  
O R D E R

Having regard to the questions involved as also the requirements on the part of each of the State, we deem it appropriate and hence direct that

in continuity with the previous orders, each of the State shall file specific affidavit, precisely advertng only to the following aspects :

- (1) Number of children with special needs;
- (2) Number of special teachers enrolled;
- (3) Number/status of vacancies;
- (4) Number of *ad hoc* teachers/special teachers appointed on contractual basis and actually working; and
- (5) The time-line within which they propose to fill up the vacancies and to meet with the requirements of this Court's orders dated 28.10.2021 and 02.05.2022.

We need to impress upon all the States concerned that short affidavits may be filed within two weeks from today precisely dealing with the aspects aforesaid and, of course, if there be any other proposition, the same may also be stated without unnecessary elaboration.

Learned counsel for the States shall also give advance copy of the said affidavits to the learned *amicus curiae*, to enable him to compile the relevant information for our consideration and to

file the same before the matters are taken up next.
