**UPON hearing the counsel the Court made the following
O R D E R**

- 1 An affidavit together with a status report dated 2 May 2022, has been filed by Dr Iqbal Singh Chahal, Municipal Commissioner of the BrihanMumbai Municipal Corporation (BMC).
- 2 The status report which is appended to the affidavit indicates the steps which have been taken by the Corporation for inviting, scrutinizing and award of the tenders for the waste water treatment facilities at seven locations, namely, Versova, Bhandup, Ghatkopar, Dharavi, Worli, Bandra and Malad. The Municipal Commissioner has stated that though it was anticipated that the work would be awarded by 15 June 2022, the process has been expedited and the work would be awarded by 31 May 2022.
- 3 We take on record the status report which has been placed before the Court by the Municipal Commissioner, who has personally appeared through the video conferencing platform.
- 4 A status report shall be filed before the next date of listing.
- 5 List the appeals on 19 July 2022.
