ACTION TAKEN REPORT

The respondent no. 2 District collector Sagar, most respectfully submit as follows:-

- 1. The Hon'ble tribunal vide its order dated 10/02/2022 directed the State Government of MP to remove the encroachment from the subjective water body in exercise to its statutory powers. The District Collector District Sagar in compliance to the directions passed by the Hon'ble Tribunal instructed the Tehsildar, Sagar vide official letter dated 03/12/2021 and also referred order no. 6513/Reader Nazul/21 dated 25/06/2021 whereby team was constituted for demarcation of subjective water body with an order to submit its report, the constituted team in compliance to the order of District Collector submitted its demarcation report on 27/09/2021 and according to the report the Lakha Banjara Lake (Sagar Talab) is encroached upon by 36 encroachers and according to the report all 36 encroachers are to be removed from the subjective water body. The copy of the letter dated 03/12/2021 is marked and filed herewith as ANNEXURE RR-2/1
- 2. The District Collector District Sagar also passed an order dated 03/12/2021 giving reference to the directions passed by Hon'ble Tribunal and the findings of the demarcation report which was

carried out the under the directions passed by the District Collector District Sagar and constituted a joint team of Revenue, Municipal Corporation Sagar, and Smart City Sagar for removal of the encroachments from subjective water body. The copy of the order dated 03/12/2021 is marked and filed herewith as ANNEXURE RR-2/2

- 3. The member of the joint team constituted by the District Collector District Sagar for removal of the encroachment District Sagar, Tehsildar Sagar issued the statutory show cause notices dated 22/12/2021 & 24/12/2021 to the encroachers which were duly received by the encroachers. The sample copy of show cause notice dated 22/12/2021 & 24/12/2021 are collectively marked and filed herewith as ANNEXURE RR-2/3.
- 4. The Tehsilsar Sagar vide letter dated 30/03/2022 has duly informed the District Collector District Sagar, that in compliance to the directions passed by Hon'ble Tribunal demarcation was carried out by the joint team constituted by the District Collector District Sagar and in furtherance to the demarcation report the District Collector District Sagar has constituted a joint team for removal of encroachments from the subjective water body subsequently, the court of Tehsildar Sagar registered the encroachment case at revenue case no. 0004/A-68/2021-22 and issued show cause notices to the 36 encroachers who had submitted their written reply to the show cause notice thereafter from 13/1/2022 to 11/02/2022 continuous hearing was conducted by the court of Tehsildar Sagar.
- 5.On 11/02/2022 show cause notices/ encroachers namely Kusum Lata Guru, Rekha Yadav and Rajan Kesarwani produced the copy of order dated 04/02/2022 passed by the Hon'ble High Court Of Mp, Principle Bench Jabalpur in WP No. -1871/2022 thereby the Hon'ble High Court of MP has directed that the operation of show cause notices issued to the encroachers therefore in compliance to the directions passed by the Hon'ble High Court the district administration has stopped the further proceedings for removal of

encroachments. The copy of the letter dated 30/03/2022 along with the order passed by the Hon'ble High Court of MP dated 04/02/2022 are collectively marked and filed herewith as ANNEXURE RR-2/4

- 6. The action taken report may kindly be taken on record and the Hon'ble Tribunal may pass appropriate order after the perusal of the report.



The petitioner no.1 to 3 are aggrieved by the show cause notices dated 22.12.2021, 13.12.2021 and 22.12.2021, respectively, whereby they have been directed to remove the encroachment from the land in question.

The contention of learned counsel for the petitioners is that demarcation was conducted by a Committee formed at the instructions of the Collector, however, no notice or opportunity of hearing was given to the petitioners regarding the said demarcation. It is submitted that proceedings under Section 248 of the MPLRC are not applicable to the case of present petitioners as they are running an eye-hospital over the alleged land and the same has been constructed after obtaining different permissions from the respondents/authorities.

Considering the aforesaid, let notices be issued to the respondents on payment of process fee within a week by ordinary as well as RAD mode, returnable within three weeks.

As an interim measure, it is directed that the effect and operation of impugned show cause notices dated 22.12.2021,13.12.2021 and 22.12.2021 shall remain stayed, till next date of hearing.
