- 1. That, I am working as Additional Director, Delhi Pollution Control Committee and am conversant with the facts of the present case on the basis of record maintained by Delhi Pollution Control Committee in its ordinary course.
- 2. That, this Hon'ble National Green Tribunal has taken up this matter suo motu on the basis of the news item titled "From oasis to forsaken Where did" appearing in the 'Hindustan Times' dated 16.08.2024 related to increased urban flooding in Delhi and its connection to the disappearance of water bodies in the capital.
- 3. That, This Hon'ble Tribunal on 30.08.2024 pleased to issue notice to DPCC, CPCB, Ministry of Jal, Delhi Watland Authority and Geospatial Delhi

Limited to file its response.



- 4. That, this Hon'ble Tribunal has taken up similar issue related to Delhi's disappearing water bodies in Original Application No. 633 of 2024 in the matter News Item titled "The curious case of Delhi's disappearing water bodies" appearing in The Hindu dated 25.04.2024. DPCC has filed its response in the said matter on 11.09.2024.
- 5. That, Wetland Authority of Delhi has been constituted vide Notification dated 25.04.2019 of Department of Environment, Forests and Wildlife, Government of NCT of Delhi for the purpose of the conservation and management of wetland for the Union Territory of Delhi. Copy of the Notification dated 25.04.2019 of Department of Environment, Forests and Wildlife, Government of NCT of Delhi is enclosed herewith as Annexure-1.
- 6. That, in compliance of decisions taken by the Integrated Drain Management Cell (IDMC) in its 17th Meeting held on 18.04.2024 w.r.t. orders of Hon'ble High Court dated 08.04.2024 in W.P.(C) No. 7594/2018 in the matter of "Court on its own motion Vs. Union of India & Ors" and W.P.(C) No. 9617/2022 "Court on its own motion Vs. Govt. of NCT of Delhi and Ors., DPCC vide email dated 20 May, 2024 received two lists of 1045 & 322 Water Bodies along with Geo-coordinates (Latitude, Longitude) from Wetland Authority of Delhi. These lists were forwarded to concerned District Magistrates vide letter dated 24.05.2024 for ground truthing etc. Copy of the letter dated 24.05.2024 issued by DPCC is enclosed herewith as Annexure-2.
- 7. That as per the information provided by Wetlands Authority of Delhi by email dated 02.12.2024 there are total 1367 Water Bodies (1045 Listed Water Bodies + 322 Water bodies identified through Satellite Imagery). Out of 1367 Water Bodies, Ground Truthing has been done in case of 674 (631+43) Water Bodies. Total Number of visible Water bodies is 674. Copy of the email dated No. 12.12.2024 of Wetlands Authority of Delhi is enclosed herewith as

Annexure-3.

22Conservation of water bodies in Delhi



- Wetland Authority for Delhi has been constituted vide notification dated 25.04.2019 of Govt. of NCT of Delhi for conservation and management of Wetlands in Delhi.
- 2. Revenue Department has carried out ground truthing of water bodies and submitted the report. Wetland Authority has decided to rejuvenate 631 number of water bodies out of 1045 listed water bodies in first phase through the land owning agencies. It is also to submit that 322 additional sites identified by GSDL were ground truthed by Revenue Department and as per the report only 43 numbers of sites were found visible on the field. Details are follows:-

- 3. Wetland Authority of Delhi requested Revenue Department to map these new 43 number of water bodies and enter the same into the revenue records and further a plan may be made by land owning agency for the restoration/rejuvenation of the water body. If the water body pertains to other land owning agency same may be intimated to Wetland Authority. The reply from Revenue Department is awaited.
- **4.** That the following action are being taken in compliance to Hon'ble Delhi High Court order dated 08.04.2024 :

- (i) Making entries of water bodies in revenue records, by assigning responsibilities of each of such water body to specific officer, who shall visit such water body every fortnight to ensure its upkeep.
- (ii) Committees responsible for ground truthing and rejuvenation of these water bodies and execution of projects at ground at District Level was constituted.
- (iii) Cleaning of water bodies through de-silting and removing of floating and other invasive aquatic plant species.
- **5.** Wetland Authority of Delhi has requested to the concerned land owning agencies to clean the water bodies through de-silting and remove floating and other invasive aquatic plant species or else any other technology suiting local conditions and submit the report.
- 6. Meeting of Wetland Authority of Delhi has been conducted under the Chairmanship of Chief Secretary, GNCTD on 09.08.2024 and the District Magistrates were directed that completion of the restoration of water bodies has to be ensured through the District Committees formed by the Hon'ble Delhi High Court order dated 08.04.2024 (W.P(C) No. 9617/2022) and it shall be ensured without fail that the work is completed after removal of encroachment before 31.12.2024.
- 7. Wetland Authority of Delhi had directed the land-owning departments vide letter No.F.5(16)/WA/WB/DIRECTIONS/2023-24/3403-3400 dated 30.10.2024 to take several measures towards protection of water bodies under their jurisdiction as well as restoration and rejuvenation of water bodies.
