**REPLY ON BEHALF OF HARYANA STATE POLLUTION
CONTROL BOARD IN COMPLIANCE OF ORDER DATED
24.05.2024.**

MOST RESPECTFULLY SHOWETH:

1. That this Hon'ble Tribunal took notice of the complainant letter stating that there is a pond (Johad) at Ambawala which has Unique Identification Registration No. 01HRKNL NSROBRAS-133 under the provisions of Haryana Water Resources (Conservation, Regulation and Management) Authority Act, 2020. It is stated in letter petition that substantial area of the pond has been encroached upon illegally by certain resourceful people and they have raised their residential constructions as a result thereof, total pond area of about 4-5 acres has reduced to 3 acre but no action has been taken by the concerned Authorities; untreated sewerage is being directly discharged in the said pond and even waste is being dumped therein, causing damage to environment and creating health hazards to the local people.

The Hon'ble Tribunal observed that the complaint raised in the matter can be looked into, at the first instance, by District

Administration. This Hon'ble Tribunal disposed of the Original Application by constituting a Joint Committee comprising District Magistrate, Karnal and Haryana State Pollution Control Board (hereinafter referred to as 'HSPCB') who shall visit the site, collect relevant information and if finds any encroachment or otherwise dumping of waste (liquid or solid) in the said pond, causing damage to the environment, shall take appropriate preventive, remedial and punitive action against the violator(s) in accordance with law, within three months from the date of communication of this order.

Upon receipt of the directions from Hon'ble Tribunal, this office wrote a letter to Deputy Commissioner requesting him for constitution of a joint team as directed by Hon'ble Tribunal by this office letter no. 1172 dt. 10.06.2024 & 1472 dt. 24.06.2024. The Deputy Commissioner Karnal directed the Departments vide letter no. 19956-19959/MA dt. 30.08.2024 and letter Endst. no. 4761-4764/MA dt. 06.03.2025 to submit action taken report urgently (**Annexure R-1 Colly**).

2. The report has been filed on 23.09.2024 by Regional Officer, HSPCB, Karnal.

3. **The Hon'ble NGT in its order dated 21.01.2025–**

(para no. 05) mentioned that –

In view of the averments made in the application and also observations made in the report of the Joint Committee, we consider it necessary to have response of (1) State of Haryana through Additional Chief Secretary, Environment, Forest and Wild

The Registry is directed to prepare and attach memo of parties to the application.

4. 5. Haryana Pond Authority also directed DDPO Karnal vide its letter dt. 28.01.2025, 14.02.2025 and 19.03.2025 to submit report (**Annexure R-3 Colly**).
6. BDPO Nissing vide letter 329 dt. 06.03.2025 requested for demarcation (Village panchayat resolution no. 01 dt. 03.03.2025) **Annexure R-4**.
7. SDM Karnal vide its order no. 1751/Steno dt. 17.03.2025 deputed Duty Magistrate for demarcation (**Annexure R-5**).
8. The demarcation was conducted on 28.03.2025 by Kanoongo-Nissing, Naib Tehsildar-Nissing in presence of BDPO-Nissing staff. The report of Halka Kanoongo-Nissing shows there are 37 no. of encroachments (marked on the map by Kanoongo with list) on the said pond. The site map regarding demarcation of land village (pond no. 315, HB No. 23, Village Brass, Tehsil Nissing) with list of encroachments is attached as (**Annexure R-6**).

Pucca Animal Sheds, 07 No. Residential Houses, 04 No. Shops & 08 No. Open Yard has been provided by the villagers on pond land (Khasra No. 315). 10 no. people are residing in these houses/open yards & approx. 25 no. of animals are in animal sheds. **The report already sent** The sizra plan submitted by Patwari alongwith Jamabandi report already sent.

BDPO Nissing also submitted record of letters mentioning request to Naib Tehsildar Nissing vide letter no.923dt. 17.11.2023 & 1998 dt. 11.01.2024 for Demarcation, on the matter of CM Window complaints received from Charan Singh S/o Labh Singh on 18.09.2023 regarding encroachment on Amba wala pond (Khasra No. 315).

Panchayati Raj Department also submitted detail of excavation done in the pond during year 2023-2024 with detail of quantity excavated with photographs showing doing excavation of the pond **with photographs.**
