	Learned Counsel for M/s Volkswagen / Respondent No. 3 filed an affidavit with regard to compliance made so far. The same is ordered to be taken on record.  Shri Mahavir Bhatnagar, Learned Counsel for M/s Win Win Automobiles which has two units and two workshops in the

city of Bhopal submits that they have made enquiry and which has relieved to them that there is also an alternative option available with M/s Vishwakarma Infrastructure which are willing to do the said job and carrying out construction of 8 urinals as already mentioned. He submits that M/s Win Win Automobiles has already placed the order and first four such toilets will be ready within 30 days from today and they will be placing order for remaining four within next 03 days and install the same within 30 days.

The other automobiles showrooms/workshops to whom notices were issued and direction for carrying out the cleanliness task have not submitted the affidavit.

The Regional Officer, MPPCB is ordered to issue notice to them to submit the compliance before this Tribunal through Regional Officer. Notice shall be served within three days and the compliance reported within three days of the receipt of the notices. It is made clear that if any of the parties are found wanting of not having made compliance, this Tribunal will issue strict orders in this behalf.
