Leave is granted.</p> <p>After hearing the Learned counsel appearing for the parties we are of the considered view that besides filing of the Status Report the State Government should file a clear affidavit by an responsible officer of the Government in the Department of Environment to state as to what is the extent of environmental degradation caused by illegal and unauthorized mining and what is the estimated environmental compensation that Respondent Nos. 6 and 7 would be liable to pay.</p> <p>As nobody is present on behalf of the Respondent Nos. 6 and 7 today as well as on the previous date of hearings, we issue bailable warrant against Respondent Nos. 6 and 7 in the sum of Rs. 20,000/- to the satisfaction of the arresting Officer, in exercise of our powers and in terms of the provision of Section 19 (4) (a) of the National Green Tribunal Act, 2010</p>
