We have presence of the Learned Counsel appearing for Ministry of Environment, Forest and Climate Change and Gujarat State Pollution Control Board and also the Respondent No. 6 Deen Dayal Port Trust.</p> <p>The State of Gujarat, Coastal Zone Management Authority and District Collector has not responded despite due Notice on them. The order dated 07th March, 2018 clearly mandates that the respondents shall respond to the interim relief pending consideration of main case. Today the respondents are duly represented and seek time to file replies. We accept their request, however in regard to interim relief sought by Respondent No. 6 Port Trust submits that the statement of the Applicant that there is construction and other activity leading to destruction of mangroves is not being done. He submits that the statement be recorded.</p> <p>In view of the fact the categorical statement there is</p>

no activity which may result in destruction of mangroves, we direct that Status quo shall be maintained till further orders. We grant four week time to all the respondents to file replies after serving copy to the applicant who may file rejoinder thereto, if any, within one week thereafter.

In the meanwhile there shall be a joint inspection conducted and report in this behalf shall be filed by the Gujarat State Pollution Control Board and Central Pollution Control Board.

As request on behalf of Respondent No. 6 following additional respondents (i) Gujarat Pollution Control Board (ii) Shree Jyoti Salt Industries and (iii) Shree Ram Salt Supply are impleaded as additional respondents. The applicant to amend the original petition and file amended petition in the registry.

Issue Notice to the newly impleaded respondents i.e. (i) Gujarat Pollution Control Board (ii) Shree Jyoti Salt Industries and (iii) Shree Ram Salt Supply. We permit Notice dasti as well.

Learned counsel takes Notice for Gujarat Pollution Control Board, waive service. Copy be given to him.
