	Item No. 1 March 5, 2015	<p>The learned Counsel appearing for the Delhi Development Authority seeks permission to file sur-rejoinder during the course of the day. He is permitted to file the same. As it is seen in the affidavit filed, out of 286 parks 39 parks are having manure pits since the park area exceeds 3 acres. It is also stated that the horticulture waste are being put in the pits regularly by employing the personnel.</p> <p>According to the DDA, in respect of other parks which are less than 3 acres, horticulture waste is being collected and the same is put into the manure pits in 39 parks. The said statement is recorded.</p> <p>The applicant appearing in person disputes the correctness of the same.</p> <p>In so far as it relates to the horticulture wastes found on the roads, it is no doubt the duty of the South Delhi Municipal Corporation (SDMC) to collect and dispose it off in environmentally friendly manner.</p> <p>The learned Counsel appearing for the said SDMC</p>

would also confirm to the same, even though they have stated in the reply that it is not their responsibility.

In such view of the matter, we direct the Executive Engineer of the SDMC to be present on the next date of hearing to explain about these contradictions.
