	Item Nos. 01 & 02 December 18, 2015 A	Learned counsel appearing for the State of Uttar Pradesh has produced the original file vide which renewal was given to the Mining Licensee in November, 2015. We

direct the file be retained in the Tribunal.

We direct the Learned counsel appearing for the State to file a complete table giving details of the persons who were/are given mining leases/licenses to carry the mining activity in Saharanpur, State of Uttar Pradesh. We direct the same be filed by Monday i.e. 21st December, 2015.

We direct the Noticees to file the copy of the Environmental Clearance granted by MoEF and Clearance granted by National Board for Wildlife.

Learned counsel appearing for the MoEF will inform the Tribunal since 2006 till date MoEF has ever conducted any inspection, particularly after the orders of the Hon'ble Supreme Court of India, to ensure and find out whether the condition of the Environmental Clearance are being complied or not.

Learned counsel appearing for the Noticees has also stated that at some point of time they were carrying on the mining mechanically, ofcourse for quite some time they are not carrying on the mining activity mechanically. We direct MoEF also to take a clear stand in that regard.
