<p><b>Item No.1 8<sup>th</sup> December, 2015 Order No.4</b></p>	<p>Heard.</p> <p>Question of implementation of the directions passed in Application No.56/2013 and Application No.57/2013 [Satish Kumar Vs. Union of India &amp; 5 others, Mahavir Singh Vs. Union of India &amp; 6 others], particularly as regards the setting up of systems for environmental friendly use and disposal of plastic wastes and for incorporation of necessary provisions in the bye-laws of the Municipalities / local bodies, arises in the present Application. Virtually it is an execution application as contemplated under Section 25 of the National Green Tribunal Act, 2010.</p> <p>Issue Notice. Service of Notice is waived on behalf of Respondent Nos.4, 5 and 6. Issue Notice to Urban Development Department of the State of Maharashtra. Notice made returnable on 11<sup>th</sup> January, 2016.</p> <p>Dasti allowed.</p> <p>We expected the Respondent No.4 MPCB to hold meeting of the stake-holders for devising and bringing into reality the systems required for environmental friendly use and disposal of plastic wastes. Learned Counsel appearing on behalf of MPCB submits that Notices were issued to the Municipal bodies / local bodies within the State of Maharashtra for the purpose of holding such meetings. He added that on November 4<sup>th</sup>, 2015 such meeting was held wherein directions were given to Municipal / local bodies in the presence and on advice of NEERI to formulate such systems.
