	Item No. 03 April 28, 2016	<p>The Learned Local Commissioner has filed the report. On inspection it was found that the IBIS Hotel has installed two Rain Water Harvesting Systems and both are similar in design and the said design is the approved design as per the CGWA. The report further shows that the Rain Water Harvesting Systems are in good and clean condition, are satisfactory and are as per the approved design. Learned Counsel appearing for the IBIS hotel submits that they have already paid the environmental compensation as directed as well as the fee due to Local Commissioner.</p> <p>The Learned Counsel appearing for the applicant submits that the hotel would maintain the conditions of the Rain Water Harvesting Systems periodically.</p> <p>In such circumstances the proceedings against such hotel IBIS is closed.</p> <p>The Learned Counsel appearing for the Jaypee Siddharth Hotel seeks permission to file objections to the</p>

report submitted by the Local Commissioner. Let Objections be filed within 10 days.

Vide order dated 23-03-2016 the CGWA, DJB and Delhi Pollution Control Committee were directed to convene a meeting and fix the procedure, and the format as well as design for the Rain Water Harvesting Systems to be installed by all hotels, hospitals and malls.

The Learned Counsel appearing for the Delhi Pollution Control Committee, DJB and CGWA submit that the meeting as directed vide order dated 23-03-2016 was convened and the minutes of the meeting is being prepared. It is also pointed out that revised guidelines were published by DJB on 18-03-2016. Let necessary be done before the next posting date.
