	and directed the State Government to express their views by
	discussing the issues with experts and others on this day fixed.

Copy of the Order was sent to the Chief Secretary, State of Rajasthan for compliance and to the Member Secretary, RSPCB for coordinating the meeting.

Learned Counsel appearing for the State of Rajasthan submits that as yet they have not been able to take decision on the issue by contacting the Experts and seeks time to submit the reply of the issues as was framed and discussed by this Bench on 19.12.2014.

Learned Advocate for RSPCB submits that in compliance of the order dated 19.12.2014, a meeting has been convened by the Addl. Chief Secretary, Government of Rajasthan with the RSPCB Member and with all the concerned officers which is scheduled to be held on 11.02.2015 for taking appropriate decision with regard to the issues framed and considered by this Tribunal in its order dated 19.12.2014. Considering this approach, we are of the view that at this present moment we cannot decide the prayer made by the Respondent interveners so long as the answers of the Respondent/State and RSPCB are not available dealing with the issues as was framed earlier.
