Order No. 8	We have heard Learned Counsel for the parties.	
August 22, 2013	The Counsel for the contractor submits that he has been	
	served only with the notice without any copy of the Application. The	
	Counsel for the Applicant undertakes to furnish the copy of the	
	Application during course of the day.	
	The Counsel for the Applicant seeks time to obtain	
	instructions pertaining to the issue of dumping of solid waste or the	
W.	waste which is caused by the Applicant. In the meanwhile, the	
2	Applicant may collect map under the RTI, in order to specify the	
	territorial limits of both the towns and also to indicate the location of	
	Dera Sandhu Ashram qua the present site used for dumping of the	
	Municipal Solid Waste. The Municipal Committee i.e. Respondent No.3 shall not continue the dumping of the Municipal Solid Waste at the proposed site unless legal permission i.e. EC is granted. The	
	Competent Authority is to take the decision for grant or refusal of the	
	EC within 15 days hereafter.	
	In the meanwhile, ad hoc arrangement is made to allow the	
	dumping as is going on but subject to condition that in case the EC	
	is refused then Respondent No. 3 will be liable to pay the amount	
	that will be determined for the restoration of the environment as well	

as for removal of the dumped Municipal Waste and also for causing of miseries to others.

The Collector of Mansa may depute a responsible officer of Rank of Deputy Collector in order to inspect the site which is being proposed for the purpose of dumping and to also to conduct work of measurement of the distance between Dera Sandhu Ashram and the proposed site to give a status report for next date of hearing. The order may be given for information to the Collector by dasti through Counsel of the State of Punjab i.e. Respondent No. 1 and liberty is granted to the Counsel for the Applicant to serve the copy of the order on the concerned Collector.
