In the meanwhile, we direct the respondents No. 4,6, 7 and 8 to verify as to whether the stone mining and crusher units involved in the present case, which are said to be operating in the state of Sahebganj in the State of Jharkhand, are also included in the orders passed in OA 44/2015/EZ and OA 88/2015/EZ earlier.

We also make it clear that this case, for the moment shall be confined only on the question of stone mining and stone crusher units in Rajmahal Hills in Sahebganj district and not on the proposed bridge over river Ganges by the Govt. of India as it falls in their policy domain.
