Items No. 5 to 8 November 20, 2013	Learned Counsel appearing for the Punjab Pollution Control Board (Mr. Takkar) would submit that in the earlier order passed by this Tribunal the Board has directed to file analysis report of samples taken

from various place in the State of Punjab and therefore it takes some time. Accordingly, he seeks four weeks time for filing a final report. However, Mr. Rao has brought to the notice of this Tribunal about the portion of the PPCB analysis report of the water Supply and Sanitation Department, Punjab Government which shows that the drinking water contained Uranium beyond the permissible limit. Therefore it requires some urgent decision. Accordingly, we adjourn finally all these matters to 12<sup>th</sup> December, 2013. The order dated 1.10.2013 in which we have given certain directions regarding the issuance of the report and copy to the Learned Amicus curie has to be scrupulously followed by the respective Counsel by the next date of hearing.

Learned Counsel appearing for the Respondent No. 1 has also filed the report and copy be given to the Learned Counsel appearing for the other side.
