Heard Sri. K. Mohanakannan, the learned counsel for the petitioner and

Sri. P.C. Sasidharan, the learned Standing counsel for the 11th respondent

2017. The official respondents in all these writ petitions are represented by the

learned State Attorney Sri. K.V. Sohan.

2. The petitioners are concerned with the failure of the State authorities

in removing/disposing of the seized and confiscated vehicles, which are seen

abandoned on the road sides and highways, and they have been cause of

accidents and traffic congestion.

3. In pursuance to the order passed by this Court, the Government have

prepared a draft disposal Scheme [Annexure R1(a)], and we find from the said

Scheme that, the various categories of seized vehicles as well as those vehicles

which are abandoned by the owners, have been taken into account. The

procedure for disposal of the seized and abandoned vehicles are formulated in

the proposed Scheme. Apart from the measures incorporated in the Annexure

R1(a), the petitioners have also forwarded their own suggestions to be

incorporated in the Scheme, and the learned State Attorney submits that all such

suggestions will be taken into account before the preparation of the final

Scheme, for disposal of the seized and abandoned vehicles.

4. In the above context, the State Attorney clarifies that the Scheme will

cover not only vehicles plying on the road but also water vessels, which are

abandoned by the owners or seized for some other reasons.

5. We have taken note of the draft Scheme as well as the suggestions

made by the petitioners. The agreement of the State Attorney to include the

water vessels in the disposal measure is also recorded. As the problem

emanating from the seized and abandoned vehicles have led to serious public

nuisance, we direct the State to finalize the Scheme within the outer limit of four

weeks' from today. It is ordered accordingly.

With the above order, the writ petitions stand disposed of.
