	Item No. 05 February 3, 2016	<p>Out of the 23 malls, shown in this order dated 30-09-2015, 4 malls were already discharged by earlier orders. Today the learned counsel appearing for the D.P.C.C made available the inspection reports regarding M/s Upaj Buildcon P. Ltd, Lifestyle Builders P. Ltd and Divine Infra P. Ltd. The reports shows that they are satisfactory vide order dated 11.05.2015 and 04.09.2015, Environmental compensation of Rs. 3 lakhs, 5 lakhs and 5 lakhs were each imposed on these malls. The learned counsel appearing for the DPCC submitted that they have already paid the environmental compensation. In such circumstances, nothing survives as against these malls and they are</p>

discharged.

The learned counsel appearing for the DPCC also made available the inspection reports in respect of 7 other malls. The counsel to serve copy of the inspection reports to the learned counsel appearing for the respective malls. Since there is some confusion with regard to item no. 8 and 9 of the list shown in the order dated 30.09.2015, DPCC has to clarify the same.
