Resident Welfare Associations of various colonies as well as to all the Hospitals-Government or private including the AIIMS Hospital, Batra Hospital, Saket City Hospital, Safderjang Hospitals, Maulana Azad Medical College, Maulana Azad Dental College, Verdhman Mahaveer Medical College, Kapoor Hospital, Max Hospital, Fortis Hospital and all other Hospitals enlisted with the NCT, Delhi or otherwise.

Notice will be issued by the Registry without process fee.

The NCT, Delhi and DPCC shall also issue Notice to all these Hospitals and bodies to state on Affidavit as to whether the Rain Harvesting System have been installed or not, and if installed whether they are functional or not, and all these hospitals be notified to appear before the Tribunal on the next date of hearing.

Notice to Resident Welfare Associations be issued by DPCC and DDA. Resident Welfare Associations will be granted liberty to represent before the Tribunal in its representative capacity.

Let copies of the Replies/objections filed by all the authorities, hospitals be provided to the Learned Counsel appearing for the DPCC and even to the others concerned.
